Dear Colleagues,

In 2020, the University of Pittsburgh committed to change its internal practices, policies and structures to make Pitt a more equitable and just university—and by so doing, to further contribute to sustainable societal change.

An important part of this commitment includes increasing Pitt's academic effort to understand and address race and the social determinants of equity, health and well-being.

Although the University currently houses great faculty expertise in these areas, it strives to significantly increase its capacity to undertake this work.

To that end, Provost and Senior Vice Chancellor Ann E. Cudd and Senior Vice Chancellor for the Health Sciences Anantha Shekhar launched the Race and Social Determinants of Equity, Health and Well-being Cluster Hire and Retention Initiative—one of the largest of its kind by any institution in the country.

Over four years and across its campuses, schools, disciplines and departments, the University will work with its deans and campus presidents to add new faculty who will conduct research, educate students, and engage in service designed to reduce racial disparities and to improve measures of equity, health and well-being in the Pittsburgh region, nationally and across the globe.

The initiative focuses on four interrelated goals:

- >> Significantly increase the number of faculty who are hired, promoted and retained who work in these fields.
- >> Attract, recruit and graduate undergraduate and graduate students for whom these issues are important.
- >> Raise the University's local, national and international profile and expertise in race and social determinants of equity, health and well-being.
- >> Increase the University's capacity to contribute to important and sustainable societal change.

In December 2020, Pitt's Race and Social Determinants of Equity, Health and Well-Being Cluster Hire and Retention Committee invited proposals from all Pitt schools and campuses to identify, recruit, hire and onboard leading scholars from around the nation to fill these faculty positions.





The book explores Haitian intellectual exile and academic diaspora homecomings after two would-be moments of social transformation in Haiti: post-Duvalier (1986-) and post-

earthquake (2010-). Her next research project will explore new Black geographies through the migrations of Haitian youth to Santiago, Chile.



As a clinician-scientist, Mickens is a funded investigator who has published on facilitators of community reintegration and resilience after spinal cord injury as well as determinants of caregiver emotional wellness during progressive neurological illness and in response to COVID 19. Her research interests and collaborations are focused on expanding the use of communitybased participatory



research models within rehabilitation populations, improving community participation after acquired disability, reducing negative mental health outcomes for caregivers and family members of individuals with progressive illness, expansion of telehealth within rehabilitation populations, and development of mobile health applications for management of mood and health behaviors after acquired injury.


